

**City of Bothell  
Revenue Development Area  
Effective January 1, 2008**

*Effective January 1, 2008*, the City of Bothell will establish a Revenue Development Area (RDA) in order to undertake community revitalization. The RDA is an area within the City of Bothell defined by the attached map. Activity within the RDA should be reported to location code 1766. The new location code represents a reporting change only; **the rate has not changed.**

Persons or businesses within the City of Bothell RDA will be subject to the new location code for reporting use tax on items purchased for their personal or business use if sales tax has not been paid.

The location codes for **sales tax** are:
